Benefits of PPA membership

Preserving and enhancing the reputation of potato and savoury snack products

- PPA exists to promote and protect the interests, values and concerns of its members. We represent the sector's views to government and relevant stakeholders throughout the UK and the EU.
- Through regular targeted stakeholder engagements and information mail outs, PPA provides a positive industry voice to media, government and opinion formers.
- PPA also acts to safeguard the reputation of the sector's products from misrepresentation in the media and other forums.

Regulatory and scientific affairs

- PPA members are kept up to date on all relevant legislative developments, voluntary Codes of Practice, scientific developments and other issues affecting the sector, both at a UK and EU level.
- PPA operates as a horizon scanner, and provides a platform for members to present their views and concerns back to government and key stakeholders.
- PPA works closely with colleagues in a number of EU and GB trade associations, including the Food and Drink Federation (FDF), European Snack Association (ESA), the European Potato Processors' Association (EUPPA), the European Potato Trade Association (Europatat), FoodDrinkEurope (FDE), GB Potatoes, the Fresh Potato Suppliers Association (FPSA) and the British Potato Trade Association (BPTA).
- Through these links we represent the sectors views to national and devolved governments, as well as European institutes.
- We have strong relationships with groups such as Red Tractor, NFU, Defra, Cabinet Office, the Food Standards Agency, Food Standards Scotland, Trading Standards, DHSC, the Advertising Association, and BRC, and we are active participants in the Business Expert Group on Food Standards & Labelling.

We also work closely with various companies and research bodies that provide inputs into UK agriculture and policy developments, such as the James Hutton Institute, CUPGRA and the John Innes Centre.

Keeping members informed

Media monitoring

Through our daily media monitoring service, we highlight important potato and savoury snack-related stories and report back on key industry issues of the day. Where articles misrepresent our products, PPA acts to provide journalists with the relevant facts, and provides a rebuttal service. PPA also engages with members through regular circulars, a monthly members-only newsletter, and through two main working groups:

The Food Law and Consumer Committee (FLC)

- Reviews UK and EU legislation and assesses its likely impact on R&D, supply chain and marketing operations of savoury snack products and processed potato products;
- Provides input into government consultations, relevant industry norms and Codes of Practice, and maintains close links with all relevant UK government departments.
- The FLC also meets to discuss and agree appropriate actions in relevant technical and legislative matters including, but not exclusively:
 - Diet & health policy, including promotion, advertising and reformulation;
 - Food labelling and standards;
 - Food hypersensitivity;
 - Food additives, flavourings and processing aids;
 - Contaminants, including process contaminants;
 - Sustainability issues, including packaging, packaging waste and recycling;
 - Food safety and process requirements;
 - Brexit, devolution and trade policy;
 - Regulatory divergence.

PPA Primary Production Technical Committee (PPTC)

- Identifies priorities for policy reform, research and innovation in all aspects of potato growing, handling, storage and processing, with the aim of optimising marketable yields, improving efficiency in the supply chain and reducing inputs and costs; allied with an emphasis on environmentally responsible production and maintaining the safety of processed potato products.
- PPTC also meets to discuss and agree appropriate actions in technical and legislative matters including, but not exclusively:
 - The impact of increasingly restrictive regulatory controls on the use of plant protection products;
 - Land policy (e.g. Domestic agriculture policy, SFI);
 - Water policy and access (impact of the Water Framework Directive and Abstraction reform);
 - Potato storage efficiency and sprout control;
 - Soil health and management;
 - Farm assurance;
 - Potential loss of land to the production of biofuels, greenbelt reviews and urban development.

Through your PPA membership you will have an opportunity to participate in both of the Technical Committees and also to have Director level representation on the PPA Board, which guides the PPA's work programme.
